The Bar Council adopted the strategic plan. The strategic plan to be published in In Brief. The President and Executive Director to liaise to determine responsibility for the various strategic initiatives.

<u>RESOLVED</u>, it was agreed that Bar Council would support a proposal to increase the NSW Judicial retirement age, but that it should be increased to 75 not 74 but this support is contingent on:

- (a) an increase in the judicial pension age to 65;
- (b) the change would be in relation to prospective appointments and would not operate retrospectively.

It was noted by the President that he is to raise the proposal with the Attorney General and the Shadow Attorney General before a public statement is issued in relation to the proposal.

<u>RESOLVED</u>, to support a proposal for the raising of the retirement age of Industrial Relations Commissioners so that it is in line with the judicial retirement age, currently 72.

RESOLVED to accept the proposal and pass the resolutions proposed.
