## **GENERAL BUSINESS**

The President left the meeting at approximately 5pm and the Senior Vice-President took over the chair.

- (a) <u>Bench and Bar Dinner</u> The Secretary advised that the President had asked him to consider changes to the format for the 2016 Bench and Bar Dinner. He requested that any Bar Councillors with suggestions in this regard contact him direct.
- (b) <u>Bar Common Room</u> The Executive Director advised that repairs were needed to a section of the Common Room Floor as a result of underlying moisture. As a result, the Common Room will be closed for the immediate future and the Bar Examinations and some CPD events will need to be held offsite.
- (c) <u>Australian Bar Association office holders</u> The Senior Vice-President noted that Patrick O'Sullivan QC had been appointed as President of the Australian Bar Association, with Wil Alstergen QC and Bruce McTaggart SC appointed to the positions of Vice-President and Treasurer respectively.
- (d) <u>Public Defenders Conference</u> The Senior Vice-President advised that he was delivering a session at the upcoming Public Defenders Conference dealing with the incidence of depression and relationship breakdown at the NSW Bar which would include material extracted from the 2014 Bar Survey and Urbis Report. The Executive had already approved the use of this information by the Senior Vice-President in accordance with the Bar Survey Data Protocol.
- (e) Philip Selth in a Representative Capacity for the Members of the Australian Bar Association v Australasian Barristers Chambers; The New South Wales Bar Association v Derek Michael Minus.

The Council notes that judgment was reserved in these two matters after a five-day hearing before Justice Greenwood of the Federal Court.
