Memorandum to the Bar Council dated 11 May 2016 from the Chair, Equal Opportunities Committee – Membership of Pride in Diversity.

<u>RESOLVED</u> to authorise the New South Wales Bar Association to become a Tier 2 member of Pride in Diversity at a cost of \$6,160 (inclusive of GST). The Bar Council, noting that such membership would involve a recurring annual expense, agreed that in the long term the focussed seminars offered by Pride in Diversity under the program should aim to deliver training primarily to members.

Letter from the President dated 12 May 2016 to Dr M Faruqi MLC – Abortion Law Reform Bill

The Bar Council agreed in principle with the President's view that the draft *Abortion Law Reform (Miscellaneous Acts Amendment) Bill* generally raised moral and ethical, as opposed to legal, considerations and that the Association should not take a public position in respect of the legislation at this stage. However, it was agreed that the Bill should be referred to the Criminal Law and Human Rights Committees for advice as to whether the Bill raised any particular substantive legal issues.
