Professor McAdam publishes widely in international refugee law and forced migration, with a particular focus on climate change, disasters and displacement. She has special expertise on cross-border relocations, especially in the Pacific, and a keen interest in the global history of refugee and migration law. She has been an expert advisor to the United Nations High Commissioner for Refugees; the International Organization for Migration; and the World Bank’s Thematic Working Group on Environmental Change and Migration.
