Speaker Profiles



The Honourable Chief Justice Bathurst AC

Chief Justice of the NSW Supreme Court

Thomas Frederick Bathurst was appointed Chief Justice of New South Wales on 1 June 2011.

Graduating with degrees in Arts and Law from the University of Sydney in 1971, he went on to practise as a solicitor in 1972. He was admitted as a barrister in 1977, specialising in corporate law and litigation and was appointed Queen's Counsel in 1987. His considerable experience in corporate law saw his appointment as a member of the Australian Government's Takeovers Panel (2006-2011).

Prior to his appointment to the bench, the Chief Justice served as President of both the Australian Bar Association (2008-2010) and the New South Wales Bar Association (2009-2011), the Executive Committee of which he was a member from 2002.

The Chief Justice was made a Companion of the Order of Australia in the Queen's Birthday Honours List in 2014.



Justin Gleeson SC

Senior Counsel, Banco Chambers

Justin has had over 30 years legal experience, as solicitor (1985 - 1988), counsel (1989 onwards), and Senior Counsel (2000 onwards). He was the founding head of Banco Chambers, Sydney (2005 - 2012). Most recently, he was the tenth Solicitor-General of the Commonwealth of Australia (2012 - 2016).

He is a Fellow of the Australian Academy of Law, a Fellow of the Chartered Institute of Arbitrators, a Member of the Permanent Court of Arbitration and a prolific legal author. He is currently in practice at the private bar as counsel and arbitrator, specialising in international law, international arbitration, constitutional law, and appellate law.



Brenda Horrigan

Partner & Head of International Arbitration in Australia, Herbert Smith Freehills

Brenda specialises in international arbitration, with a particular focus on disputes involving emerging markets, and has worked from the US, Paris, Moscow, Shanghai and now Sydney. She works with clients on complex international commercial and investment treaty arbitration matters at both the arbitration and enforcement stages, acts as counsel in matters conducted under a wide variety of arbitration rules, and also sits as an arbitrator. Her background as a transactional lawyer provides valuable insight for clients into the underlying commercial and contractual aspects of the disputes on which she advises.

In addition to her work as counsel, Brenda has spoken at many conferences and seminars on both arbitration and the challenges of investments in emerging markets. She is the past co-chair of the China Committee of the American Bar Association (ABA) Section of International Law, and served for several years as Global Adjunct Professor of Law at New York University Law School (Shanghai campus). Brenda is an Executive Director of ACICA. She is fluent in English, French and Russian.



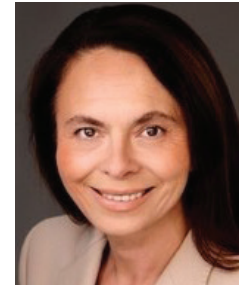
Khory McCormick
