Call for Papers: Proposals for sessions and abstracts (max 250 words) are invited for individual papers (20 mins) or panels on any aspects of relevance to four key themes. One is rural crime as offences against pastoral, agricultural and aquaculture industries. The second concerns the issues around the policing of rural crime, and the third concerns the laws and policy and practice relating to rural crime including the legal and criminal justice response in prosecuting and punishing offenders. The fourth takes a criminological approach to consider the social context in which various social and crime problems occur within rural communities.
