

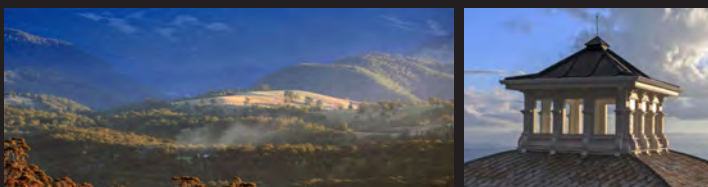

Conference Venue
