In March 2015, the changes to the *Privacy Act 1988*, introduced by the *Privacy Amendment* (*Enhancing Privacy Protection*) *Act 2012*, turn one year old!

The reforms marked a profound change in the legal and regulatory structure of Australia's privacy regime; seeing the introduction of new rights and obligations and a substantial change in the enforcement regime, including the introduction of new civil penalty provisions.


