Special Resolution: Proposed Amendment to Terms of Reference and Rules of WBF AGM, 4 June 2015

Pursuant to Rule 18 of the Women Barristers Forum Terms of Reference and Rules, amend the Terms of Reference and Rules by:

1. The addition of new Clause 19A:

19A. Non-profit clause

The assets and income of the Forum shall be applied solely in furtherance of its above-mentioned objects and no portion shall be distributed directly or indirectly to the members of the organisation except as bona fide compensation for services rendered or expenses incurred on behalf of the organisation.

- 2. Amend clause 22(1) by:
 - (a) deletion of the words:
 - (i) "the net assets of the Forum" after "dissolution"; and
 - (ii) "shall be disposed of to" after "arm of"; and
 - (b) insert after "dissolution" the words:

"the amount that remains after such dissolution and the satisfaction of all debts and liabilities be transferred to another organisation with similar purposes and which has rules prohibiting the distribution of its assets and income to its members, which may be a non-profit charitable arm of"

So that clause 22(1) reads:

22. Dissolution of Forum

(1). Should the Forum be dissolved for any reason, upon its dissolution, the net assets of the Forum the amount that remains after such dissolution and the satisfaction of all debts and liabilities shall be transferred to another organisation with similar purposes and which has rules prohibiting the distribution of its assets and income to its members, which may be a non-profit charitable arm of shall be disposed of to the NSW Bar Association.
