He practices principally in commercial litigation, trade practices and administrative law and was listed in the Australian Financial Review's Best Lawyers list in 2015 for Commercial Law, Human Rights Law, Intellectual Property Law and Litigation. In 2009, Julian was awarded an Officer of the Order of Australia (AO) for his work as a human rights advocate and for his services to the arts and the law.

She was Assistant-Professor, University in Lublin, Poland and was seconded to the Ministry of Justice to work on harmonisation of Polish laws with international standards and has also worked on UN judicial and legal reform programmes in Bosnia and Afghanistan.
