FOR CONSIDERATION

Policy Brief from the Criminal Law Committee – Drug Law Reform

Stephen Odgers SC, Chair of the Criminal Law Committee, spoke to the Committee's report and answered questions on the proposals from Bar Councillors. Odgers SC withdrew from the meeting before the Bar Council discussion on the policy brief.

The Bar Council thanked Odgers SC, the Committee and the Association's Senior Policy Lawyer, Ms Megan Black, for their work in producing such a far reaching and comprehensive paper.

Bar Council <u>noted</u> that the Association had publicly advanced similar proposals under the Presidency of Handley QC. It was agreed that the previous papers should be provided to Bar Councillors.

<u>RESOLVED</u> that Bar Council give further consideration to the paper at a dedicated meeting to be held in three months' time. Odgers SC and Megan Black will attend the meeting to provide Bar Council with a comprehensive presentation on the paper and its implications.

 - (b) Peak legal profession organisations
 - (c) Law Reform Commissions
 - (d) Relevant government departments
- 2. From time to time, the Executive Director can review and amend the list of organisations followed by the Association's social media accounts.
- 3. Unless the President directs otherwise, the Association's social media accounts shouldn't 'like/favourite', 'comment' or 're-tweets' by other organisations, as this might be construed as endorsement of their views.'
