

The Forbes Society is pleased to inform members of the upcoming **joint presentation with the Ngara Yura Committee** of the Judicial Commission of NSW on **Tuesday 3 June 2025** at **5.30 pm, in Banco Court, Level 13 Law Courts Building**. This year's joint event will explore the "Towards Truth" Research Project. <u>Towards Truth</u> is a partnership between the Indigenous Law Centre and the Justice and Equity Centre (formerly the Public Interest Advocacy Centre). The project is researching the vast body of laws and policies that have impacted First Nations people since 1788, broken down into four main 'themes' – Country, Kinship, Law and Culture, and People.

Her Honour Judge Sarah Hopkins (Ngara Yura Committee) will facilitate the presentation and introduce **Anna Harding** (Project Director of Towards Truth) and **Elizabeth Clark** (Research Lawyer with the Towards Truth Project).

The 14<sup>th</sup> Annual **Plunkett Lecture** will be delivered by the NSW Solicitor General, Michael Sexton SC on 23 October 2025, in Banco Court.
