## Monday 18<sup>th</sup> December 2023

### *2023 Invitational Challenge*

#### **NOTICE OF RACE - DISTRIBUTION: ALL BARRISTERS, JUDGES AND SOLICITORS**

Solicitors are invited to compete in the 40<sup>th</sup> GBBR in a friendly competition with Bench & Bar. This is a non-spinnaker race for monohull keelboats > 6.5m. The Organising Authority is the RAN Sailing Association ("RANSA").

#### **Start Time:**

**11:00 am on Monday, 18 December 2023**

*Start Line:* Vicinity Shark Island/Point Piper

*Course:* Final details will be provided in Sailing Instructions (about 2 1/2 hours race). The course will be similar to that of the last 39 years.

*Finish:* Store Beach

*Post-race Activities:* (i) Picnic on Store Beach (ii) Presentation of trophies on Store Beach. (TBC) **Entry Fee per Boat: \$190.00**

Any money raised from the race will be donated to Charity.

**We should all be Covid-19 conscious.**

Sailing Instructions will be provided to all confirmed and accepted entrants on Thursday, 14 December 2023. Entries close **noon 13 December**. Any entries considered after that date will have a worse handicap.

## CONDITIONS OF ENTRY AND COMPETITORS DECLARATION

### INSURANCE

- The Bar Association's and Organising Authority's current insurance policies do not cover this activity. **It is a strict condition of entry** that all skippers have arranged appropriate third party, property and personal injury insurance, to cover themselves, their crew and their guests for the duration of the event. Please provide copy of relevant current insurance details. Boats will not be entered into the race until a copy has been received.

### INDEMNITY

- All skippers/owners participating in the Great Bar Boat Race hereby agree to indemnify and keep indemnified the NSW Bar Association, and organisers of the said event, the RAN Sailing Association, their servants or agents in respect of any injury, loss or damage occurring to their boat and themselves or their crew, or claim, as a result of their participation in the said race.

I agree to be bound by the current World Sailing Racing Rules of Sailing and by all other rules that govern the event including the Notice of Race and Sailing Instructions and these conditions of entry and Marine Safety Regulation 2016. I have read and understand my obligations as set out in the AS Special Regulations 1.02 Owners Responsibility. I certify that the vessel entered will maintain, during period of racing, an insurance policy with a minimum of \$10,000,000 (ten million dollars) Public Liability cover for any one incident, a copy of certificate of insurance is attached.

I agree to (i) abide by all lawful traffic directions of NSW Maritime Boating Service Officers and (ii) report all incidents involving a fatality, serious injury and/or damage (where such is considered significant having regard to the types of vessels involved) at the first reasonable opportunity and, in any case within 48 hours of occurrence, to the Race Committee of the RAN Sailing Association and to RMS irrespective of whether a valid Protest is lodged in relation to any such incident.

I consent to my entry details being distributed to Organising Authority, other competitors, handicapper, Race Committee and organisers.

By signing this entry form I declare that I will read and agree to be bound by the entry conditions contained in the Notice of Race and Sailing Instructions. Particular attention is drawn to clause Risk Warning, clause Competitors Declaration, clause Decision to Participate, and clause Disclaimer of Liability as detailed in the Sailing Instructions.
