## AGREEMENT FOR THE PROVISION OF LEGAL SERVICES AS AN APPROVED BARRISTER IN THE NSW WORKERS COMPENSATION SCHEME

This Agreement is made on the ..... day of .....20.....

between the Workers Compensation Independent Review Officer (**the WIRO**)

and .....(the Barrister)

1. The WIRO has established a list of Approved Barristers which is published on the WIRO Website.
2. The WIRO has established a list of Approved Lawyers who are Australian legal practitioners practising as solicitors approved by the WIRO to receive funding to provide legal services to injured workers in respect of workers compensation matters under the *Workers Compensation Act 1987 (NSW)* and the *Workplace Injury Management and Workers Compensation Act 1988 (NSW)* (the NSW workers compensation legislation).
3. Barristers on the list of Approved Barristers are Australian legal practitioners approved by the WIRO to receive payment for legal services either directly or under a brief from an Approved Lawyer in relation to a matter the subject of a WIRO grant of funding.
4. The Barrister has applied to become an Approved Barrister and the WIRO has approved that application. The legal practitioner will be referred to as the Barrister in this Agreement.
5. This Agreement starts on the date of its execution by the WIRO and continues until the Barrister withdraws from or is removed from the list of Approved Barristers.
6. The Barrister may request to be removed from the list of Approved Barristers.
7. The WIRO may publish the Barrister's name, Chambers, business address, email address and telephone number on the list of Approved Barristers that appears on the WIRO website. The WIRO may also publish this information in any other form that the WIRO considers appropriate.
8. The Barrister may promote their status as a WIRO Approved Barrister.
9. The WIRO may refer Approved Lawyers to the list of Approved Barristers maintained on the WIRO website to select an Approved Barrister.
10. The Barrister will accept briefs from WIRO Approved Lawyers to:
  - a. give legal advice,
  - b. appear as an advocate,
  - c. represent a client in a conciliation conference, arbitration hearing or other method of alternative dispute resolution,
  - d. negotiate for a client with an opponent to compromise a case,
  - e. prepare or advise on documents to be used by a client or by others in relation to the client's case
  - f. carry out any other work properly incidental to the kinds of work referred to above, or



such other work as is from time to time commonly carried out by barristers in relation to work required under a WIRO ILARS grant of funding.

11. The Barrister acknowledges and agrees to be bound by the fees for Counsel set by WIRO in the Disbursements Schedule in the ILARS Grant Amount Guide for all work performed.
12. The Barrister will maintain a current practising certificate issued by the NSW Bar Association or interstate equivalent, without any condition, restriction or qualification that would limit or restrict the Barrister’s capacity to accept briefs from Approved Lawyers or directly from injured workers.
13. Comply with the provisions of the Legal Profession Uniform Conduct (Barristers) Rules 2015 (as amended from time to time).
14. Comply with any Guideline, Practice Direction including e bulletins or other document issued by the Workers Compensation Commission that sets expectations in relation to conduct of hearings, including commencement times, appearances, briefing and client conferences.
15. Notify the WIRO immediately in writing of any criminal charges (except in relation to minor traffic offences), bankruptcy or professional disciplinary proceedings commenced against the Barrister.
16. Notify the WIRO immediately in writing if the Barrister ceases to hold a current practising certificate during the term of this Agreement or if, as a consequence of disciplinary proceedings, the Barrister is prevented from practising as a barrister.
17. Immediately cease to provide legal services to Approved Lawyers where the Barrister ceases to hold a current practising certificate during the term of this Agreement or if, as a consequence of disciplinary proceedings the Barrister is prevented from practising as a barrister.
